Further, Participant/Guardian does for him/herself, his/her heirs and personal representatives, hereby defend, hold harmless and indemnify, release and forever discharge the College of Engineering and the University of South Alabama, its trustees, officers, agents, servants and employees from and against any and all claims, demands and actions or causes of action on account of or resulting from participation as aforesaid.

If Participant is a minor (under the age of 19 years) and suffers an injury or illness while participating in this event, Guardian expressly authorizes the employees of the University of South Alabama to use full discretion to transport or to have the minor transported to a medical facility, and Guardian agrees to take full legal and financial responsibility for such actions.
