Note: For out-of-state new residents, first-time issuance of an Alabama driver's license, suspended driver's license, or a foreign national driver license, you MUST apply at the Alabama Department of Public Safety Office address above (Demetropolis). Alabama driver's licenses will not be issued or renewed for those who do not have more than 6 months on their I-20/DS-2019.

- The Alabama's Driver License Manual is available online at http://dps.alabama.gov/documents/manuals/driverlicensemanual.pdf. Read the book to help you study for your driver's test. A learner's permit <u>is not</u> a driver's license. It is a permit to learn to drive. You <u>must</u> have a person with a driver's license in the car with you when driving.
- 2. If you do not have a Social Security card, you must request a denial letter first from the Social Security Administration (SSA) stating you are ineligible for a Social Security number.
- 3. Take the driver's license letter you receive from the Office of Immigration and all immigration documents (I-20/DS-2019, valid passport, valid visa, I-94 arrival page) to the Social Security Administration and request a denial letter.
- 4. Take the SSA denial letter, driver's license letter from the Office of Immigration, and all immigration documents (I-20/DS-2019, valid passport, valid visa, I-94 arrival page to the Department of Motor Vehicles (DMV). You may request an appointment for first-time license by visiting the Mobile County License Commission at www.mobilecountylc.com.
- 5. Alabama license fee is \$37.50.
- 6. In the State of Alabama, liability automobile insurance and wearing a seatbelt (even as a passenger) are **MANDATORY**.

- 1. Must be registered in SEVIS prior to applying for a Social Security number.
- 2. Take employment offer letter, Office of Immigration letter, all immigration documents (I-20/DS-2019, valid passport, valid visa, I-94 arrival page) to the Social Security Administration to apply for a number.
- 3. It generally takes 2 weeks for the card to arrive to your address.
- 4. Do **not** give your SSN to a stranger over the phone, a friend/family member, or carry the card in your wallet. Take care of any business you need (I-9, W-2, opening bank account) and put the card in a safe place.
